Ada Voumard, 93, died at 4:40 a.m. Thursday, August 23, 2012 at Jerseyville Nursing & Rehab. in Jerseyville. Born October 16, 1918 in Foster Township, she was the daughter of Adolph and Carrie (Brueggemann) Patsink. She was a member of the Salem Presbyterian Church in Alton and retired in 1983 from the Alton Mental Health Center. On November 30, 1939 in Fosterburg, she married Roy Voumard. He preceded her in death on October 25, 2006.
